PORT OF VANCOUVER USA BOARD OF COMMISSIONERS REGULAR MEETING Tuesday, November 28, 2023

CALL TO ORDER

Commission President Orange called a regular meeting of the Port of Vancouver Board of Commissioners to order and open to the public at 9:30 a.m., Tuesday, November 28, 2023, at the Port of Vancouver USA Administrative Office, 3103 NW Lower River Road, Vancouver, Washington 98660.

OPENING REMARKS

Commissioner Orange welcomed everyone to the commission meeting. He announced no executive session was held and that the meeting is being recorded. He stated the meeting is a hybrid meeting, and along with everyone present in the meeting, anyone who wants to make virtual oral comment can use Zoom. He then invited guests to participate in the Pledge of Allegiance.

APPROVAL OF MINUTES

Special Meeting/Executive Session Minutes of the November 13, 2023

On motion by Commissioner Burkman, seconded by Commissioner LaBrant and carried unanimously, the Board of Commissioners approve the minutes of the November 13, 2023, special meeting/executive session.

Regular Meeting of November 14, 2023

On motion by Commissioner Burkman, seconded by Commissioner LaBrant and carried unanimously, the Board of Commissioners approve the minutes of the November 14, 2023, regular meeting.

Community Fund Update - Vancouver Farmers Market

Community Relations Manager Julie Rawls stated the port's Community Fund program awarded funds to the Vancouver Farmer's Market this year. She indicated the market has a program to help traditionally marginalized vendors that provides free space and training necessary to help nurture these small businesses. She stated these small businesses greatly contribute to Vancouver's tourism, economic development, and overall livability. She indicated that this also furthers the port goals of economic development as well as diversity, equity, and inclusion. She then introduced Stephanie Clark and Jordan Boldt from the Vancouver Farmer's Market.

Ms. Clark provided an overview of the Vancouver Farmer's Market Foundation and thanked the port for its support. The Board expressed their appreciation to Ms. Clark for her presentation and work on this program.

Holiday Card

Katie Odem, Marketing Communications Manager introduced this year's Holiday Card. She thanked the port's consultant DCI for their work on the project and invited everyone to share the card.

CALL TO ORDER

Port of Camas-Washougal CEO David Ripp called the Joint Clark County Ports Boards of Commissioners Special Meeting to order on Thursday, November 30, 2023, at 12:33 p.m. at the Port of Camas/Washougal Administrative Office, 24 S. "A" Street, Washougal, WA 98671.

WELCOME AND INTRODUCTIONS

Port of Camas-Washougal CEO Ripp welcomed and thanked everyone in attendance and invited attendees to introduce themselves.

PORT SUSTAINABILITY UPDATE AND DISCUSSION

Port of Vancouver Director of Economic Development Mike Bomar provided an update on the port's Climate Action Plan and answered questions. Ports of Camas-Washougal CEO Ripp and Ridgefield CEO Randy Mueller also provided an update on sustainability efforts taking place at their port and answered questions.

TAX INCREMENT FINANCING

Mike Bomar, Port of Vancouver Director of Economic Development provided a presentation on Tax Increment Financing and the Port of Vancouver's Tax Increment Area (TIA) followed by a discussion with the other ports and their plans with Tax Increment Financing opportunities.

LEGISLATIVE UPDATE

Port of Camas-Washougal CEO Ripp, Port of Vancouver Director of Economic Development Bomar, and Port of Ridgefield CEO Mueller reported on the three Clark County Ports 2024 Joint Legislative Agenda. There was also discussion about the upcoming Washington Public Ports Association (WPPA) Legislative Day and Hill Climb in Olympia.

COMMISSION DISCUSSION

I/5 Bridge Replacement Project

In Port of Vancouver Commissioner Jack Burkman's absence, Director of Economic Development Bomar gave a brief high-level update on the project and answered questions that were raised.

Appoint RTC Port Representative and Alternate

Port Commissioners discussed the Regional Transportation Council 3-ports representative. After discussion, Port of Ridgefield Commissioner Joe Melroy made a motion to reappoint Port of Vancouver Commissioner Burkman as the 3-ports' primary representative and Port of Camas-Washougal Commissioner Larry Keister as the alternate representative replacing Port of Ridgefield Commissioner Scott Hughes who fulfilled his appointment. Commissioner Eric LaBrant seconded the motion and all board members voted in favor.

CREDC Strategic Planning Update

Columbia River Economic Development Council President and CEO Jennifer Baker gave a brief update on their Strategic Plan.

SUBJECT:	Approve Lease Agreem	ent between the Port of Vancouver US	A and Axium

BACKGROUND:

This lease agreement supports the port's Strategic Plan goals to pursue opportunities that utilize the port's property and infrastructure investments to create jobs and support the economy.

Headquartered in Ohio, Axium Packaging LLC ("Axium") manufactures packaging for personal care, household products, over-the-counter pharmaceuticals and food grade markets. Since 2011, Axium has grown to 18 facilities in North America and over 3,000 employees. Axium's processing capabilities include injection molding and extrusion and injection blow molding using state of the art equipment. Axium has a focus on sustainability by sourcing pellets comprised of recycled materials and using electric equipment with closed loop water and air systems that are maintained with plant-based oils. This facility is strategically located in close proximity to customers to minimize transportation miles and ultimately reduce their carbon footprint.

The purpose of this lease is to provide Axium a 7-year lease effective January 1, 2024 with two options to extend for 5 years each in BL3300 Section B. The premises consists of 88,877 sf of warehouse space including 3,837 sf of office space and a breakroom on a site area of 124,768 sf. Axium will initially employ 30 full-time employees.

If approved, the value of this lease over the initial term is approximately \$6,404,073 plus additional charges for leasehold excise tax, common area maintenance, building insurance and stormwater recovery. In consideration of this lease agreement the port will construct a demising wall, ensure electrical utilities are separated and exclusive to Axium, and provide a \$100,000 construction allowance for building improvements and alterations.

A portion of this revenue was included in the 2024 approved budget.

SUBJECT:	Approve Resolution 4-2	023: Sell and Convey Port Property	

BACKGROUND:

RCW 53.08.090 allows a port commission, by resolution, to authorize the managing official of a port district to sell and convey port district property of \$22,000 or less in value.

Beginning July 23, 2023, port commissions may authorize the managing official to sell and convey any property up to \$22,000, which was previously at \$10,000. The state Department of Revenue adjusts this figure every December based on changes in the Seattle area CPI-U index.

Annually, the port Commission approves a resolution giving the port's CEO the authority to carry out this function. This resolution and action item provides that annual authority.

The resolution shall be in force for not more than one calendar year from the date of resolution and may be renewed from year to year.

RESOLUTION 4-2023

A RESOLUTION OF THE PORT OF VANCOUVER BOARD OF COMISSIONERS AUTHORIZING THE CEO TO SELL AND CONVEY PORT PROPERTY OF \$22,000 OR LESS IN VALUE

WHEREAS, from time to time certain items of Port of Vancouver USA property are no longer suitable or necessary for district purposes; and

WHEREAS, such property may have remaining value; and

WHEREAS, RCW. 53.08.090 authorizes the port commission to delegate to the managing official of a port district the authority to sell and convey port district property of \$22,000 or less in value, which is not a part of the comprehensive scheme of improvements or modifications thereof.

NOW, THEREFORE, BE IT RESOLVED that the CEO is authorized to sell and convey port district property having a value of \$22,000 or less in value which is no longer suitable or necessary for district purposes, and which is not a part of the comprehensive scheme of improvements or modifications thereof.

Prior to any such sale or conveyance, the CEO shall itemize and list the property to be sold and make written certification to the commission that the listed property is no longer needed for district purposes.

This resolution shall be in force for not more than one calendar year from the date of resolution, unless rescinded by commission action.

ADOPTED by the Port of Vancouver, USA Board of Commissioners on the 12th day of December, 2023, and signed in authentication of its adoption.
