SUBJECT:Approve Change Order #4 for Public Works Contract Bid 22 – 34: Berth 17 Rehabilitation Project		2 – 34: Berth	

BACKGROUND:

The Berth 17 Rehabilitation project supports the port's Strategic Plan goal of pursuing opportunities that utilize the port's property and infrastructure investments to create jobs and support the economy.

On August 23, 2022, a contract for the project was awarded to Advanced American Construction, Inc. of Portland, OR in the amount of \$10,035,232.27. Change orders #1, #2 and #3, in the amounts of \$95,588.50, \$170,086.77, and \$2,748.31 respectively, including Washington state sales tax, totaled \$268,423.58, and were previously approved by authority of the CEO.

The CEO's Authority under Resolution 10-2022 requires Commission approval for change orders that cumulatively exceed \$300,000. Change order #4, in the amount of \$37,205.74, brings the cumulative amount of change orders #1 through #4 to \$305,629.32, including Washington state sales tax, and therefore requires Commission approval.

Change order #4 is necessary for the procurement of materials to construct corner guards for dolphins, which are necessary for safety at the berth.

This project was included in the approved 2023 budget. The port has sufficient funds for change order #4.

BACKGROUND:

This agenda item supports the port's Strategic Plan goal of pursuing opportunities that utilize the port's property and infrastructure investments to create jobs and support the economy.

The port is planning current and future projects requiring additional electrical service in the Terminal 4 & 5 areas including service to the Berth 17 Rehabilitation project. Clark Public Utilities (CPU) is in the business of installing electrical utilities and supplying electrical power within Clark County, including to the port and its tenants. This Utility Work Agreement is necessary to establish and carry out the work necessary to provide adequate services for the Berth 17 Rehabilitation Project, future tenant infrastructure expansion projects at Terminal 4 & 5, as well as to provide a mechanism for the port to reimburse CPU for the cost of construction.

Specifically, this project will install new medium voltage electrical service cables from existing CPU power sources located near the port's administration buildings on Lower River Road and extend them out to the southwest corner of Terminal 5. The new service cables will be installed in existing underground conduits that were previously installed for this purpose. New service vaults will be installed near Subaru parking facilities in Terminal 4 and Berth 17 to provide additional electrical services to these current and future tenant locations. This work is anticipated to start in late January or early February and be completed by the end of August 2023.

CPU's estimated cost for this project is \$689,862.53 including Washington State sales tax. Actual material and labor costs will be charged by CPU and paid for by the port in accordance with the Utility Work Agreement. This project is included in the 2023 approved budget.
