**\$3,400** total vendor fees covered



- Concrete-Reinforcing Structure Work
- Ground Level Utility Foundation Work
- West Tower Elevator Shafts and Core Shear Wall Foundation



#### *Terminal 2 Pond Remedy Project* CONTRACTOR: BELLA TERRA LLC

- Project 100% complete Just finished
- 3 inch coarse compost mulch added
- Installation of biofiltration pond plants





#### *Terminal 2 Berths 3 & 4 Paving Project* CONTRACTOR: WESTERN UNITED CIVIL GROUP

- Project 85% complete
- Cement Treatment Base 100%
- Waiting on weather to proceed with paving







### *Terminal 3 2022 Paving Project* CONTRACTOR: GRANITE CONSTRUCTION COMPANY



- Project 100% complete
- Grind and inlayed in 13 hours
- 1350 tons of asphalt




# Terminal 4 Bank Stabilization CONTRACTOR: TAPANI INC.

- Armoring of the bank complete.







# Berth 17 Rehabilitation Project CONTRACTOR: ADVANCED AMERICAN CONSTRUCTION, INC.

- Constructs in-water replacement dolphins
- Constructs new catwalks; upland mooring anchors
- Constructs upland and on-berth utilities
- Electrical power; upland civil site improvements; misc.
- Repairs damaged pile under approach trestle
- Removes the Colby crane and associated gallery



# Berth 17 Rehabilitation Project CONTRACTOR: ADVANCED AMERICAN CONSTRUCTION, INC.



- Contractor mobilized equipment to the berth
- Demolition of the catwalks has started



# Building 2480 Roof Coating & Panel Replacement CONTRACTOR: SPRAY-ON FOAM, BATTLE GROUND WA



- Project 100% completed as of October
- Coated approx. 21,000 sq. ft.
- Replaced 38 Translucent Panels
  - With replacement of the panels, tenant no longer needed to increase their warehouse lighting




# Building 2500 Warehouse & Office Painting CONTRACTOR: NW REMODEL & DESIGN, VANCOUVER WA

- Project 95% complete
- Painting around truck bays and storage area remaining
- Gutter and downspout replacement on warehouse space will start soon, as a separate contract with Snugs Services



# Building 2565 Fire System Replacement CONTRACTOR: COSCO FIRE PROTECTION, VANCOUVER WA

- Project 90% complete
- Sprinkler heads in office to be installed
- COSCO inspection found that the sprinkler lines need to be replaced in upper office areas; however, office area below can be flushed.
  Contractor will need additional time to complete this work.
- Main and branch lines completed in warehouse





# Building 3201F & 3103 HVAC Installation CONTRACTOR: STEWART MECHANICAL

- Project 100% Complete
- HVAC system installed in both buildings





### 2022 Fire System Flushing CONTRACTOR: FIRE SYSTEMS WEST, VANCOUVER WA

- Project 2% complete
- Building 2851 (Plastics NW) -Flush one zone (170) requiring hydropneumatics method on mainlines only
- Building 2501 (Country Malt)
  - Flush five zones (130, 132,

Building 2501 - Zone 136 Main Lines

133,134 and 136) including mains and branch lines utilizing hydropneumatics method

 Building 2401 (Metro Metals) - Flush three zones (146-148) requiring hydraulic method on mainlines only
