



- Project 95% Complete
- Sprinkler heads in office to be installed
- Some branch lines to be replaced in upper office area
- Main and branch lines install completed in warehouse
- Project should be completed by middle of February



#### 2022 Fire System Flushing CONTRACTOR: FIRE SYSTEMS WEST, VANCOUVER WA

- Project 80% Complete
- Building 2851 (Plastics NW) 100% Completed
- Building 2401 (Metro Metals) 100% Completed
- Building 2501 (Country Malt) Flush five zones; lines on east side dock have been completed along with 10% of the lines in the interior
- Project will be completed by December 30th



#### Backflow Prevention on Kotobuki Way CONTRACTOR: CLARK & SONS, BATTLE GROUND WA

- Project 75% Complete
- 2" Reduced pressure backflow assembly installed at BL2100 and BL2400
- Electrical being installed this week at BL2400
- Bollards, gate and fencing to be completed next week
- Project will be completed by December 30<sup>th</sup>



#### Building 3201 Roof Repair CONTRACTOR: QUEEN CITY ROOFING, BRIER WA



- Project 65% Complete
- Skylight fall protection being installed
- Flashing repairs are 90% completed
- Roof coating repairs are 90% completed
- Fastener replacement should be completed by December 21st
- Gutter replacement to start December 26<sup>th</sup>
- Project will be completed by the end of February
