Freight Infrastructure

- Provide investment for the replacement of the Columbia River I-5 bridge and other SW Washington transportation projects that facilitate freight movement, economic development, job growth, address key chokepoints and grade-separation.
- Support efforts to close transportation funding gaps and meet freight mobility needs throughout Washington State.
- Support Columbia River ports' efforts to maintain 43' shipping channel.
- Promote a high, wide, and heavy corridor through the Columbia River region and support funding for the planning and construction of the corridor.
- Support reliable freight funding for infrastructure and construction programs.

Environment

Ensure carbon pricing in Washington both efficiently and effectively reduces the state's transportation-induced greenhouse gas emissions. Dedicate revenue generated from carbon pricing to the full scope of Washington's transportation infrastructure. Enhance allowances or exemptions for Energy Intensive Trade Exposed (EITE) industries like agriculture and forestry, to protect these important enterprises.

Establish grant programs that incentivize ports and their partners to become more environmentally sustainable and efficient.

Amend the Climate Change Grant program (RCW 36.70a.190) to allow port participation. Provide greater certainty and timeliness in permitting decisions and environmental reviews. Evaluate rulemaking by Ecology on SEPA as it relates to assessment and mitigation of project-related greenhouse gas emissions and seek legislative clarity where needed.

Protect funds in the Model Toxics Control Account for cleanup activities. Support efforts to shift the Vessel Excise Tax to the Derelict Vessel Account.
